Pro-rated amounts apply only to new members. Exceptions are as follows: Annual Club Dues: Everyone pays the \$40.00 annual club dues except current officers, charter and OFGC Life members. A Life membership is currently set at \$500.00, which covers only the annual club dues. Life members are still responsible for the annual Range Maintenance Fee.
