Membership Renewal Fees

Membership runs January through December and costs \$140.00 (dues of **\$50.00** plus a range maintenance fee of **\$90.00**). Pro-rated amounts apply only to *new members*. Exceptions are as follows:

- **Annual Club Dues:** Everyone pays the **\$50.00** annual club dues except current officers, charter and OFGC Life members. A Life membership is currently set at **\$500.00**, which covers only the annual club dues. Life members are still responsible for the annual Range Maintenance Fee.
- **Range Maintenance Fee (RMF):** Members **65** years of age at the time of renewal are not required to pay the **\$90.00** RMF. Members under 65 years of age may reduce or eliminate the RMF for the following year by providing approved services during the current year. A credit of **\$10.00** is earned for each hour of service provided to the club. Fee may vary annually.
- **Family Membership:** Associate memberships are extended to the immediate family of the applicant. Immediate family being defined as the spouse and unmarried children *under 21* enrolled in school. At age 21, individual membership is required. Associate members have all the rights of the applicant except the right to vote on official club business.
- **Corporate memberships** are not allowed.

The information I have given above is true and correct.
