## **Membership Renewal Fees**

*Membership runs January through December and costs <u>\$140.00</u> (dues of <u>\$50.00</u> plus a range maintenance fee of <u>\$90.00</u>). Pro-rated amounts apply only to <i>new members*. Exceptions are as follows:

- Annual Club Dues: Everyone pays the <u>\$50.00</u> annual club dues except current officers, charter and OFGC Life members. A Life membership is currently set at <u>\$500.00</u>, which covers only the annual club dues. Life members are still responsible for the annual Range Maintenance Fee.
- **Range Maintenance Fee (RMF):** Members <u>65</u> years of age at the time of renewal are not required to pay the <u>\$90.00</u> RMF. Members under 65 years of age may reduce or eliminate the RMF for the following year by providing approved services during the current year. A credit of <u>\$10.00</u> is earned for each hour of service provided to the club. Fee may vary annually.
- **Family Membership:** Associate memberships are extended to the immediate family of the applicant. Immediate family being defined as the spouse and unmarried children *under* 21 enrolled in school. At age 21, individual membership is required. Associate members have all the rights of the applicant except the right to vote on official club business.
  - Corporate memberships are not allowed.
