Membership Renewal Fees

Membership runs from January through December and costs **\$140.00** (dues of **\$50.00** plus a range maintenance fee of **\$90.00**). Pro-rated amounts apply only to *new members*. All fees may vary annually. Exceptions are as follows:

- **Annual Club Dues:** Everyone pays the **\$50.00** annual club dues except current officers, charter and OFGC Life members. A Life membership is currently set at **\$500.00**, which covers only the annual club dues. Life members are still responsible for the annual Range Maintenance Fee, if applicable.
- **Range Maintenance Fee (RMF):** Members **65** years of age at the time of renewal are not required to pay the **\$90.00** RMF. Members under 65 years of age may reduce or eliminate the RMF for the following year by providing approved services during the current year. A credit of **\$10.00** is earned for each hour of service provided to the club.
- **Family Membership:** Associate memberships are extended to the immediate family of the applicant's household. Immediate family being defined as the spouse & unmarried children under 19 *or* under 21 if enrolled in school. At age 21, individual membership is required. Associate members have all the rights of the applicant except the right to vote on official club business. Youths under age 18 must be accompanied by an adult with a membership badge. Youths 18-20 not accompanied by a member will need a youth badge and must be listed with birth date on this form.

The information I have given above is true and correct. I understand that any falsification of entries on this application, subsequent criminal convictions, or failure on my part to abide by club Safety Rules and regulations will be grounds for the immediate termination of club membership.
